



## Edmonton Area Alberta Dressage Association 2022 Education Subsidy Programs

The Edmonton Area Alberta Dressage Association (EAADA) Board is pleased to announce that we have expanded the Education Subsidy Program for 2022 through the addition of an *EAADA Young Rider Subsidy*. The intention of the Education Subsidy Programs is to financially support the dressage education of EAADA members.

*The EAADA is pleased to be able to offer the Education Subsidies to its members. It is only through the time of dedicated volunteers, the financial support of members and the development of youth that can we continue to promote the future of dressage in Alberta.*

**The newly expanded EAADA program has two streams:**

**Stream 1: The All Ages Rider Education Subsidies (AARES), and**

**Stream 2: The Alberta Youth Dressage Development Program (AYDDP) Subsidy**

### **Stream 1: All Ages Rider Education Subsidy (AARES)**

AARES Subsidies are reimbursements for expenses incurred and paid at the end of the year, based on available funding and the number of applications received.

To be eligible, members claiming AARES must have volunteered a minimum of 3 hours time in support of EAADA programs and activities during the year. Volunteer activities include, but are not limited to:

1. Volunteering at any Equine Canada recognized dressage show in the province
2. Organizing dressage clinics in the Edmonton Area
3. Volunteering at any EAADA event (i.e. transporting or billeting judges, clinicians; hosting a social or roving lecture, being on the executive)
4. Working the ADA casinos, the Mane Event ADA booth, etc.

Please contact for more information on volunteer opportunities or if you have questions regarding whether or not your volunteer activities qualify.

#### AARES Guidelines:

1. The applicant may request reimbursement for a combination of clinic and lesson fees paid in 2022 to a maximum of \$150.00, as follows:
  - a. \$50.00 per dressage clinic;
  - b. \$50.00 for each set of 5 dressage lessons.
2. The primary focus of the lessons and/or clinics must be dressage.
3. The applicant must be an EAADA member in good standing;
4. The applicant must not have applied for and received subsidy under any other ADA education program for the lessons and/or clinics named on the application, including the AYDDP.
5. The intent of AARES funding is for the education of the rider, thus subsidies are applied to the RIDER.
6. The monies payable will be determined by the EAADA Executive based on the financial health of EAADA during the fiscal year. There are no guarantees of subsidy monies being payable. Based on the popularity of the program, applicants may receive only a percentage of the total amount requested, so that all riders submitting forms will receive equal access to funding.
7. **Subsidy Forms will be accepted no later than January 5, 2023. The form must be completed in full and the full names and signatures of the clinic organizer and instructors are required.**

## Edmonton Area Alberta Dressage Association 2022 Education Subsidy Programs

### Stream 2: The Alberta Youth Dressage Development Program (AYDDP) Subsidy

EAADA's AYDDP Subsidies are advance payments to cover a portion of expenses to be paid for participation in a dressage skills development clinic. Subsidies are based on available funding, which is capped at \$1000.00 for the year, and the cost of the session.

#### AYDDP Guidelines:

1. The applicant may request subsidy for no more than 50% of fees to attend an upcoming clinic in 2022 to a maximum of \$150.00 per calendar year.
2. The applicant must be between the ages of 6 and 25 in the year in which they are applying.
3. The youth for which the subsidy application is being made must be an EAADA member in good standing.
4. The primary focus of the clinic must be dressage.
5. The intent of AYDDP funding is for the education of the rider, thus subsidies are applied to the RIDER.
6. **Subsidy Forms will be accepted no less than two weeks in advance of the clinic date. Applicants are recommended to submit their forms as soon as they are able.**
7. The form must be completed in full.
8. Applicants must provide confirmation of having secured a spot (e.g. email) and the full name and contact information of the clinic organizer for verification.
9. Applicants must attach a description of how they plan to make a contribution to the EAADA and/or Alberta Dressage through engagement, volunteer or other means.
10. The monies payable will be determined by the EAADA Executive based on the financial health of EAADA during the fiscal year. There are no guarantees of subsidy monies being payable.
11. The EAADA would greatly appreciate that the application send a short video of their participation following the clinic, which could be shared on social media.

#### Examples:

The applicant has confirmed that they/their child has secured a rider's spot and are able to attend a two-day clinic with an instructor from out of province. The cost of participation in the two days is \$400.00. The applicant can request no more than \$150.00 from the AYDDP subsidy.

The applicant has confirmed that they/their child has secured a rider's spot in a one-day clinic focused on prix caprilli with an instructor from their region. The cost of participation is \$80. The applicant can request \$40.00 from the AYDDP subsidy for this clinic. If the applicant attends another clinic later in the year, they are able to apply for additional subsidy up to \$110 (\$150 – \$40).
